Any previous training card must not have expired more than six months prior to the "sell by date" this includes ALLMI's licences.

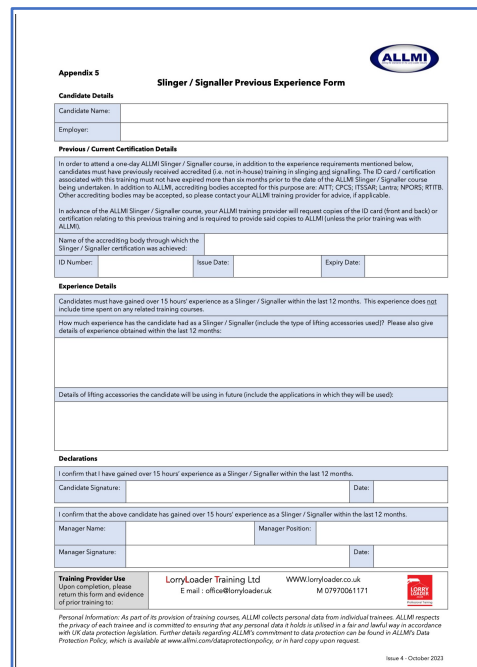
